Storage period

Your personal data will be saved as long as you are a borrower with us. You are automatically erased if you have not used the library's services in 5 years. Data on the lending of media that consists of several parts, such as language courses and CD books, is saved for 90 days following the loan period. Data on the lending of other media is only saved during the loan period.

Data that is shared

The personal data we process about you is shared with our system providers. We may also share your personal data with a third party, provided that we are obliged to do so by law.
